Circular No. 190 of 2017

ORDER

WHEREAS the Maharashtra State Legislature has enacted the Maharashtra Public Universities Act, 2016 and the said Act has come into force w.e.f. 1st March 2017, vide Notification No. MPUA-2015/(319/15) UNI-4/Part-2, dated 23rd February, 2017 issued by the State Government;

AND WHEREAS as per the provisions of Section 28 (2) (y) of the Maharashtra Public Universities Act, 2016, one member of Municipal Council or Municipal Corporation, shall be nominated by the Vice-Chancellor, as a member of the Senate for a tenure of one year by rotation;

AND WHEREAS as per the provisions of Section 28 (2) (z) of the Maharashtra Public Universities Act, 2016, one representative of the Education Committee of Zilla Parishads within the University area, shall be nominated by the Education Committee, as a member of the Senate for a tenure of one year by rotation;

AND WHEREAS as per Section 32 (3) (g) of the Maharashtra Public Universities Act, 2016, two teachers, representing each faculty, with not less than fifteen years of teaching experience are to be elected by the collegiums of teachers from amongst themselves, out of whom one each shall be a person belonging to Scheduled Castes or Scheduled Tribes or De-notified Tribes (*Vimukta Jatis*)/ Nomadic Tribes or Other Backward Class, provided that the reservation per faculty shall be decided by drawing lots and out of the teachers representing each faculties, one shall be a woman, to be decided by drawing lots.

AND WHEREAS Sub-Section 8 of Section 12 of the Act provides that where any matter is required to be regulated by the Statutes, Ordinances or Regulations and no Statutes, Ordinances or Regulations are made in that behalf, the Vice-Chancellor may, for the time being, regulate the matter by issuing such directions as he thinks necessary;


THEREFORE, I, Prof (Dr.) Nitin R. Karmalkar, Vice-Chancellor of the Savitribai Phule Pune University, by and under the powers vested in me under Sub-Section 8 of Section 12 of the Act, hereby issue the following directives:

- 1) In view of the provisions of Section 28 (2) (y) of the Maharashtra Public Universities Act, 2016, the Vice-Chancellor shall nominate one member of Municipal Council or a Municipal Corporation for a tenure of one year, by rotation, by drawing lots. The manner in which the rotation for nomination of a member of a Municipal Council or a Municipal Corporation, shall take place for the first and succeeding years, shall be as shown in Appendix I. The rotation in the same manner shall continue thereafter for the successive years.
- 2) The Municipal Council or Municipal Corporation represented once on the Senate from any particular Group, shall not be represented again until the remaining Municipal Councils or Municipal Corporations in the respective Groups mentioned in Appendix I have had their turns.
- 3) The Municipal Councils or Municipal Corporations coming into existence hereafter shall be included in the Groups mentioned in Appendix I by drawing lots.
- 4) In view of the provisions of Section 28 (2) (z) of the Maharashtra Public Universities Act, 2016, one representative of the Education Committee of Zilla Parishads within the University area, shall be nominated as a member of the Senate for a tenure of one year by rotation, by drawing lots. The manner in which the rotation for nomination of a representative of the Education Committee of Zilla Parishads, shall take place for the first and succeeding years, shall be as shown in Appendix II.

- 5) In view of the provisions of Section 32 (3) (g) of the Maharashtra Public Universities Act, 2016, for the purpose of election of a member belonging to Scheduled Castes or Scheduled Tribes or De-notified Tribes (*Vimukta Jatis*)/ Nomadic Tribes or Other Backward Class and for a woman member on the Academic Council, determined by drawing lots shall be as shown in Appendix III:
- 6) The manner in which rotation is fixed shall not be changed for any reason, whatsoever, other than that mentioned in this Order.

This Order shall come into force with immediate effect and shall remain in force till the Uniform Statutes in this regard are prescribed by the State Government or Statutes in this regard are framed by the University, whichever is earlier.






